ORDINANCE NO. 13-01-131

FIXING THE PRICE PER SQUARE METER OF BURIAL LOTS IN THE NEW PUBLIC CEMETERY OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The price per square meter of burial lots sold in the New Public Cemetery of Bulalacao, Oriental Mindoro shall be fixed in the following manner; to wit:

- i. For each burial lot consisting of:
4 m. x 5 m. = 20 sq.m x Php500.00 = Php10,000.00
- ii. For each burial lot consisting of:
1.5 m. x 2.5 m. = 3.75 sq.m. x Php250.00 = Php937.50.00

In case of excess, the price shall be Php500.00 per sq. m.

SEC. 2. The amount imposed in this ordinance shall be paid to the Municipal Treasurer upon execution of Deed of Sale between Municipal Government of Bulalacao and the Vendee duly notarized and no structure whether permanent or temporary or interment of deceased shall be permitted unless the same is fully paid.

SEC. 3. Notarial fee pertaining to the sale of burial lots shall be paid by the Municipal Government of Bulalacao, Oriental Mindoro.

SEC. 4. Any person who owned a burial lot or lots by virtue of Deed of Sale with the Municipal Government of Bulalacao shall have no authority to re-sell such burial lots without the consent of the latter.

SEC. 5. Any construction of any kind or nature in the New Public Cemetery, whether temporary or for perpetual use shall be allowed only upon issuance of the corresponding permit by the Mayor, upon recommendation of the Municipal Health Officer and after payment of the required fees to the Municipal Treasurer in accordance with the Municipal Revenue Code.

SEC. 6. All Ordinances inconsistent hereof are hereby repealed, modified accordingly.


SEC. 7. Any violation hereof shall be punished by the fine of Php2,500.00 or imprisonment of not exceeding six (6) months or both such fine and imprisonment at the discretion of the Court.


SEC. 8. Effectivity. This Ordinance shall take effect immediately.




