**MUNICIPAL ORDINANCE NO. 18-03-202**

**AN ORDINANCE IDENTIFYING CERTAIN RIVERS AND WATER CHANNELS IN BULALACAO, ORIENTAL MINDORO AS POSSIBLE SOURCES OF FILLING OR MIXING MATERIALS FOR PUBLIC AND PRIVATE CONSTRUCTION PURPOSES**

**Be it ordained** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**Section 1.** The following rivers and water channels within the jurisdiction of this municipality are hereby identified as possible sources of filling or mixing materials for public and private construction purposes:

- a. Cavillan River in Sitio Cavillan, Barangay Nasucob
- b. Caguray River in Barangay Benli
- c. Piri Creek in Barangay San Juan
- d. Cawacat River in Sitio Candayao, Barangay Cambunang

**Section 2.** Applicants for quarry permit shall be advised by the officer of LGU of Bulalacao authorized or designated to perform functions of a Municipal Environment and Natural Resources Officer (MENRO) to secure resolutions of recommendation from the Sangguniang Bayan and concerned Sangguniang Barangay and certificate of no objection from the Municipal Mayor prior to submission of the application for quarrying activities to appropriate offices in the Provincial Government of Oriental Mindoro (PGOM).

**Section 3.** The Provincial Mining Regulatory Board, the Sangguniang Panlalawigan of Oriental Mindoro, and the Office of the Provincial Governor may refer to this Ordinance in acting on applications for permit to conduct quarry activities within the jurisdiction of Bulalacao, Oriental Mindoro.

**Section 4.** If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.

**Section 5.** This Ordinance shall take effect immediately after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.
