WHEREAS, Item 1 of Section 4 of the Revised Guidelines in the Naming and Renaming of Streets, Public Schools, Plazas, Building, Bridges and other Public Structures declares that street, plaza or any public place may be named or renamed to honor a person or family who contributed to the welfare of the Filipino people;

WHEREAS, Don Gabriel Contreras served as Gobernadorcillo and Captain Municipal of Bulalacao, Oriental Mindoro in the 19th Century;

WHEREAS, evidences, courtesy of the National Archives of the Philippines confirmed a Spanish colonial document containing the signatures of the Principalia of Oriental Mindoro where Don Gabriel Contreras signatures found at the upper right of the document;











NOW, THEREFORE, BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in session assembled that;

Section 1. The covered court located at Sitio Caw-ayan, Barangay Poblacion Bulalacao, Oriental Mindoro is hereby named as Gabriel Contreras Multi-Purpose Building Cum Evacuation Center.

Section 2. The Municipal Engineering Office is tasked to paint the name of Gabriel Contreras Multi-Purpose Building Cum Evacuation Center in front part of the building upon approval of this Ordinance and use the name in all its official functions and transactions.

Section 3. Effectivity. This Ordinance shall take effect upon its approval.
