PANG FOR THE ESTABLISHMENT OF THE BLOOD SAMARITAN PROGRAM AIMS TO PROVIDE FREE AND TIMELY ACCESS TO SAFE AND QUALITY BLOOD FOR INDIGENT PATIENTS OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO AND SUCH OTHER TERMS AND CONDITIONS THAT MAY BE AGREED UPON BY BOTH PARTIES

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (MOA) is entered into by and between:

The **PHILIPPINE RED CROSS**, an independent and autonomous non-governmental humanitarian organization recognized under Republic Act 10072, with postal address at # 37 EDSA, CORNER Boni Avenue, Mandaluyong City, and represented by its Secretary General, **DR. GWENDOLYN T. PANG**, hereinafter referred to as the "**PRC**" or the **FIRST PARTY**;

-and-

The **LOCAL GOVERNMENT (LGU) BULALACAO**, a local government unit (LGU) under Republic Act No. 7160, with address at Poblacion, Bulalacao, Oriental Mindoro, herein represented by its Mayor, **HON. LUMELITO M. CABAGAY**, and hereinafter referred to as the "**LGU**" or the **SECOND PARTY**;

WITNESSETH THAT

WHEREAS, under Section 2 of the Republic act 10072, otherwise known as the Philippine Red Cross act of 2009, the PRC shall provide humanitarian relief and assistance in times of peace and armed conflict. In addition, under Section 3 of the same law, the PRC is recognized as the voluntary, independent, autonomous nongovernmental society auxiliary to the authorities of the Republic of the Philippines in the humanitarian filed, to assist said authorities in discharging the obligations set forth in the Geneva Conventions and the Statutes of the International Red Cross and Red Crescent Movement;

WHEREAS, one of the purposes of the PRC is to cooperate with public authorities in the prevention of diseases, the promotion of health and the mitigation of human suffering by their own programs in such fields as education, health, and social welfare, for the benefit of the community, pursuant to Section 4 of the Republic Act No. 10072;

WHEREAS, to allow the PRC to fully utilize its mandate, one of the privileges granted to it under Section 5 of the RA 10072, is to enter into agreements with public authorities, and accept provisions for the cost of any service or activity which may be entrusted to it, within the scope of its object and functions, pursuant to such agreements;

WHEREAS, the Philippine Red Cross (PRC) has been undertaking the Blood Samaritan Program throughout the country, which is aimed mainly to assist indigent patients needing blood transfusion. The PRC seeks individuals/groups who are willing to give financial donations to support blood needs of the indigent patients;

WHEREAS, PRC- Mindoro Oriental Chapter has been implementing Blood Service in the whole province, as one of the major services of the organization and became more operative and functional upon the establishment of a Blood Collecting Unit/ Blood Station (BCU/BS) situated inside the premise of Calapan City Hall, Guinobatan;

WHEREAS, PRC-Mindoro Oriental Chapter was granted of a Blood Collecting Unit/Blood Station and became fully operational on January 2023, whose end goal and objective are to maintain and sustain adequate supply of blood for the indigent patients;

WHEREAS, the **LGU of BULALACAO** as a Local Government Unit, is mandated by Republic Act No. 7160 to promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, the Philippine Red Cross seeks to engage into an Agreement with the LGU of **BULALACAO** to establish, within their jurisdiction **THE BLOOD SAMARITAN PROGRAM**;

WHEREAS, pursuant to CHAPTER IV, (Relations with People's and Non- Governmental Organizations) Section 35 & 36 of the RA 7160, the **LGU of BULALACAO** is authorized to enter into cooperative undertakings, or agreements, and provide assistance, financial or otherwise, to POs and/or NGOs for projects that will enhance the social well-being of the people, to be implemented within its territorial jurisdiction;

NOW, THEREFORE, for and in consideration of the foregoing premises, and for purposes of the proper and efficient implementation of the **BLOOD SAMARITAN PROGRAM**, the parties to this Memorandum of Agreement (MOA) agree as follows:

1. The Philippine Red Cross and the **LGU of BULALACAO** shall jointly implement the **BLOOD SAMARITAN PROGRAM** for the deserving / indigents / in-crisis patients who are residents of Bulalacao, who are either confined or out-patient in any hospitals within and outside the province, private or government- owned hospitals;
2. The **LOCAL GOVERNMENT OF BULALACAO** shall allocate an amount of at least ONE HUNDRED THOUSAND PESOS (Php100,000.00) for the year starting 2025 to 2027 to support the Philippine Red Cross in the implementation of the **BLOOD SAMARITAN PROGRAM**, and shall cause either **TRANSFER OR RESERVATION** of Funds in favor of the PRC;
3. That if the Fund is transferred, the PRC will issue Official Receipt in acknowledgement of the amount granted and shall be liquidated through submission of Consumption Report to the Finance Department of the LGU of BULALACAO, and with full compliance to accounting and liquidation rules and regulations, with corresponding names of the grantees;
4. That if the Fund is NOT TRANSFERRED but allocated to solely support the processing/screening fees for blood requested, the Philippine Red Cross shall send or submit Billing Statement every quarter, or semi-annually, or depending on the terms and agreement of the parties;
5. That the **LGU of BULALACAO** shall replenish or replace the utilized amount subject to the availability of LGU funds for sustainability and continuity of the Blood Samaritan Program;
6. That the PRC- Mindoro Oriental Chapter shall continuously monitor the implementation of the Program and shall coordinate regularly with the donor-LGUs to maintain smooth and continuous flow of the program;
7. The PRC- Mindoro Oriental Chapter and the **Municipal Health Office (MHO) of BULALACAO** shall jointly evaluate blood request of the patient who shall be covered by the Blood Samaritan Program; and the requirements and processes set and agreed by both parties shall be applied in determining the right and deserving patients;
8. If the patient/client requesting/needing blood for transfusion is outside the province and confined in hospitals, the PRC Chapter...

person on a 24/7 open communication for emergency blood needs to ensure effective and smooth flow of referral system in providing blood assistance to the individuals in need of blood transfusion;

9. The PRC- Mindoro Oriental Chapter shall submit semi-annual report to the LGU of Bulalacao for purposes of transparency, evaluation, monitoring and liquidation of disbursed funds;
10. The LGU of Bulalacao shall likewise support the PRC in advocating and promoting the DOH National Voluntary Blood Donation Service Program (NVBS) by encouraging the public and all its residents to volunteer and participate in the implementation of Blood Service as well as the Blood Samaritan Program of the PRC;
11. To ensure proper implementation of the Blood Samaritan Program, the LGU of Bulalacao and the PRC shall create a committee that shall be responsible for monitoring the program, including systems and procedures, time schedules for the release of funds, the PRC's periodic reporting and liquidation;
12. Any of the parties shall have the freedom to terminate the agreement, however, the party shall notify in advance the other one (1) month prior to date of revocation of contract;
13. This Memorandum of Agreement shall take effect upon signing of this document by both parties,
14. This Memorandum of Agreement (MOA) shall remain valid for a period coterminous with the present administration, renewable thereafter, subject to annual joint review and evaluation.
