WHEREAS, if these Mangrove trees will be cut, fish and other wildlife animals will surely vanish;

WHEREAS, flood always occur in this Municipality caused by the River of Cavillian which lies along these Mangrove trees;

WHEREAS, if these Mangrove trees will be cut, flood will surely caused damage to the houses and crops near the river bank;

WHEREAS, this Honorable Body hereby request the Minister, Ministry of Natural Resources and the Director Bureau of Forestry, that the Mangrove trees in this Municipality which are not within the fishpond area be declared reserved for the interest of the general public;

NOW, THEREFORE, resolved, as it is hereby resolved to request the Minister, Ministry of Natural Resources and the Director Bureau of Forestry, not to issue License or permits to persons to cut Mangrove trees cut the area of fishponds in the Municipality of Bulalacao, Oriental Mindoro.
