The meeting was called to order at 9:30 O'clock in the morning.

The calling of the roll was performed by the Recorder with the members answering present when their respective names were called.

The minutes of the previous meeting was also read by the Recorder and there no objection so on motion of Hon. Ulpiano C. Pandino, seconded by Hon. Amparo S. Gregorio, the minutes stands as confirmed.

The letter from Mr. Helgie Faballa, teacher of Bulalacao Municipal High School, as well as the letter from INP Station Commander and the letter from the teachers of the Central School of this Municipality was read to this body. Said letter was held in abeyance pending the arrival of the Municipal Treasurer, for consultation on the next meeting.

Hon. Ulpiano C. Pandino moved and seconded by Hon. Edilberto M. Pajila, the enactment of a Resolution granting scholarships to Grade Valedictorians and First Honors high school students in the Municipal High School of this Municipality. Likewise the tuition fees of the students in the Municipal High School is increased effective, this school year 1981. This was moved and seconded by Hon. Modesto C. Bacawag, seconded by Hon. Juanita T. Amparo... UNANIMOUSLY APPROVED.

Hon. Ulpiano C. Pandino, moved and seconded by Hon. Edilberto M. Pajila for the suspension of the meeting at 10:30 in the morning to entertain, OFL Angel Llave of the PC-INP of this town who was invited to confer with this Body about the report of the complainant in certain case filed before the local court to the Municipal Mayor, that the prisoners had escaped from jail in the PC-INP Barracks and were still at large at present.

The presiding Officer asked the Station Commander regarding the subject matter. The Police Officer admitted that there are three prisoners who had escape but the case of one of the escapee was already arraigned. Llave said the prisoners had escaped under the custody of somebody in this town, so he must be given time to locate the same and bring him back to justice.

The Sangguniang Bayan of Bulalacao, on motion of Hon. Modesto O. Bacawag, seconded by Hon. Amparo S. Gregorio,

RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 8

INCREASING THE TUITION FEES IN THE MUNICIPAL HIGH SCHOOL OF BULALACAO, ORIENTAL MINDORO.

WHEREAS, the basic tuition fees of the students from First year up to Fourth year in the Municipal High School of Bulalacao, Oriental Mindoro, the previous years is ₱12.00, monthly;

WHEREAS, the rate of tuition fees paid monthly by the students cannot meet the demand of the school expenses, as well as the salaries of the Eleven teachers;

WHEREAS, Bulalacao Municipal High School has the lowest tuition fees as compared to other Municipal High schools in Oriental Mindoro and therefore, the Sangguniang Bayan of Bulalacao, hereby Ordains that:

Section 1.- All students in the Municipal High School of Bulalacao, Oriental Mindoro are hereby required to pay monthly fees, the amount enumerated as follows to wit: First year and second year - ₱13.00; Third year and Fourth year ₱14.00, monthly, respectively;

Section 2.- Tuition fees in the Municipal High School of this town shall be paid in five (5) installment basis as enumerated hereunder:

- a) June to July - 1st installment
- b) August & Sept. - 2nd installment
- c) October & Nov. - 3rd installment
- d) December & Jan. - 4th installment
- e) February & March - 5th installment

Section 3.- Arrangement of the above fees shall be made in the Office of the Municipal Treasurer of Bulalacao, Or. Mindoro.

Section 4.- Violation of this Ordinance or parts thereof, shall be fined the amount of ₱25.00 to ₱200.00 or an imprisonment of 5 days to 10 days or both such fine and imprisonment at the discretion of the Court.

Section 5.- Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 6.- This Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that copies of this Resolution be furnished, the Regional Director, Ministry of Education and Culture, Region IV, Manila for consideration, and approval.
