The Sangguniang Bayan of Bulalacao, on motion of Hon. Perpetuo C. Cantos, seconded by Hon. Juan L. Salas,

RESOLVED, to approve the following Ordinance:

ORDINANCE No. 6

TO CONSTRUCT FISH PORT AT THE PIER OF BULALACAO, ORIENTAL MINDORO AND TO REQUIRE FISH DEALERS TO UNLOAD ALL FISH AT SAID FISH PORT FOR TAXATION PURPOSES

WHEREAS, fish is one of the sources of Income of this Municipality;

WHEREAS, hundreds of kilos of fish were brought to town for commercial purposes;

WHEREAS, in order to raise the revenue of this municipality, the Sangguniang Bayan, hereby Ordains that:

SECTION 1. Fish Port shall be constructed at the pier of this municipality where all kinds of fish will be brought and weighed for taxation, with the following rate:

- a) Fresh fish - - - - - ₱0.10 per kilo
- b) Dried fish - - - - - 0.10 " "

SECTION 2. Fish owners/dealers are not allowed to unload fish in any other place of this town except in the fish port specified in Section 1, hereof;

SECTION 3. Violation of this Ordinance or parts hereof shall be fined the amount of ₱200.00 to ₱500.00 or an imprisonment of 10 to 30 days or both such fine and imprisonment at the discretion of the court;

SECTION 4. Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 5. This Ordinance shall take effect immediately;

UNANIMOUSLY APPROVED.

There having no other business to be transacted so on motion by Hon. Jose P. Paigao, seconded by Hon. Juan L. Salas, the session was adjourned at 12:00 AM.
