WHEREAS, Bulalacao Municipal High School has more than 400 students, with new school site situated at Sitio Odiong, this municipality;

WHEREAS, nearby jetmatic hand pump could not support the water consumption of more than 400 students;


WHEREAS, because of their subject, Gardening, and for their source of drinking water and other uses, there is a need to construct Artesian Well inside the premises of Bulalacao Municipal High School;
