APPROPRIATING THE SUM OF ₱8,160.00 TO BE TAKEN FROM THE INCREASE OF TUITION FEES IN THE BULALACAO MUNICIPAL HIGH SCHOOL

SECTION 1. There is hereby Appropriated the sum of ₱8,160.00 to be taken from the increase of tuition fees in the Bulalacao Municipal High School from ₱23.00 to ₱27.00 for First year and seconde year and from ₱24.00 to ₱28.00 for Third year and Fourth year a month, effective August 1, 1985 for salary adjustment of teachers and other expenditures;

SECTION 2. This Ordinance shall take effect immediately.
