RESOLUTION NO. 3

REQUESTING THE REGIONAL DIRECTOR, BUREAU OF FOREST DEVELOPMENT, THROUGH THE DISTRICT FORESTER, ROXAS, ORIENTAL MINDORO TO RELEASE THE ELEVEN HECTARES OF SWAMPY AREA LOCATED AT CAMPASSAN, BULALACAO, ORIENTAL MINDORO IN FAVOR OF THE MUNICIPALITY OF BULALACAO.

WHEREAS, a portion of Lot No. 671, FDS-395-D, located at Barangay Campassan, Bulalacao, Oriental Mindoro, containing an area of Eleven Hectares (11) more or less is a Forest Land;

WHEREAS, the Municipal Council of Bulalacao on its regular session held on May 30, 1970 have passed Resolution No. 31, reserving six (6) of these Eleven (11) hectares as Municipal Government property: (a) two hectares for the market site; (b) two hectares for Bulalacao Municipal High School site; and (c) two hectares for Municipal Government site;

WHEREAS, improvements were introduced by the Municipal government of Bulalacao by constructing a Public Market and its stalls since in 1968;

NOW THEREFORE, resolved as it is hereby resolved to request the Regional Director, Bureau of Forest Development, Quezon City, through the District Forester, Roxas, Oriental Mindoro to release the eleven hectares of Forest land located at Barangay Campassan, Bulalacao, Oriental Mindoro in favor of the Municipal Government of Bulalacao;
