" RESOLUTION NO. 95-05-026

ENGAGING THE LEGAL ASSISTANCE OF ATTY. EDGARDO C. ACERON AS LEGAL COUNSEL IN CONNECTION WITH CIVIL CASE NO. 255 ENTITLED RODOLFO V. DAYANGHIRANG, ET AL VERSUS THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO AND OTHER RELATED CASES; AND AUTHORIZING THE MUNICIPAL MAYOR TO NEGOTIATE WITH ATTY. ACERON CONCERNING ATTORNEY'S FEES AND OTHER RELATED MATTERS

"WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro is, under Civil Case No. 255, accused by Rodolfo V. Dayanghirang and Nenita Yang for Forcible Entry and Damages with Temporary Restraining Order and/or Preliminary Mandatory Injunction;

"WHEREAS, this case was filed by the said plaintiffs when the Municipal Government of Bulalacao, Oriental Mindoro started to construct a public market at Barangay Campaasan which site was claimed by both Rodolfo V. Dayanghirang and Nenita Yang;

"WHEREAS, the Municipal Government of Bulalacao on 1969 through its Council's various resolutions, had adjudicated for its favor a portion of an agricultural land covered by Lot No. 671-PLS-395-D to be used as sites for public market, community high school, and municipal government;

"WHEREAS, the Municipal Government, aware of its dual functions, first; as an agency of the National Government in the discharge of public or governmental functions and second, to perform corporate or business functions not strictly political or governmental in nature: established on 1970 a public market for the use of inhabitants on the said adjudicated portion of lot;

"WHEREAS, the Municipal Government of Bulalacao maintains that it has acquired public dominion over the contested portion of lot since 1969 and the ensuing documents issued in favor of the plaintiff on 1974 are contrary to the public interests;

"WHEREAS, since the matter of ownership over the lot in question is now brought to the attention of the Court, the services of a competent lawyer are necessary in order to represent the Municipal Government, Now, therefore, be it:


RESOLVED, AS IT IS HEREBY RESOLVED, That: The legal assistance of Atty. Edgardo C. Aceron be engaged as legal counsel of this Municipality in


