EARNESTLY REQUESTING THE HONORABLE NOLI S. DE CASTRO, SENATOR REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF ONE UNIT THREE CLASSROOM BUILDING AT MAUJAO NATIONAL HIGH SCHOOL SITUATED AT BARANGAY MAUJAO, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO.

"WHEREAS, Section 17, Article II of the Constitution provides that the State shall give priority to education, arts, culture and sports to foster patriotism and nationalism, accelerate social progress and promote total human liberation and development;

"WHEREAS, the newly-opened Maujao National High School has only two classroom building that there is a dire need to construct additional rooms to accommodate the enrollees thereat;

"WHEREAS, the opening-up of the secondary school mentioned above was made due to the effort of the Local Government Unit of Bulalacao wherein it appropriated the necessary amount for the salaries and other emoluments of the two (2) teachers thereat and provided various school facilities and amenities for the benefits of the students;


