"WHEREAS, the LTFRB is responsible for promulgating, administering, enforcing and monitoring compliance of policies, laws and regulations of public land transportation system;

"WHEREAS, the said agency is in charge of granting franchise or accreditations and regulating public vehicles such as utility buses, mini buses, public utility jeepneys, express buses, filcab service, school services, taxis, Transportation Network Vehicles Services (TNVS) and tourist transport services;

"WHEREAS, currently, the franchise of the route plying from Bulalacao to Roxas and vice versa is being granted to Mindoro Transport Service Cooperative (MINTSCO), however, for the longest time, it is not operating which abandoned the said route leaving it unusable for public transport;


