EARNESTLY REQUESTING THE REGIONAL DIRECTOR, BUREAU OF FISHERIES AND AQUATIC RESOURCES, REGION IV TO IMMEDIATELY CONDUCT OCULAR INSPECTION AND INVESTIGATION ON THE 59 HECTARES OF FISHPOND LEASE AGREEMENT SITUATED AT SITIO TABOK, BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the 59 hectares of Fishpond Lease Agreement situated at Sitio Tabok, Barangay Poblacion, this Municipality which was previously granted to Mr. Arnulfo Sison was cancelled by the Bureau of Fisheries and Aquatic Resources due to his failure to develop the area;

"WHEREAS, since the cancellation of the Fishpond Lease Agreement, encroachment have been made by the people without securing permit from the Municipal Government of Bulalacao or from BFAR;

"WHEREAS, there is a dire need for the BFAR to conduct ocular inspection and investigation on the 59 hectares of the Fishpond Lease Agreement so that proper recommendation be made to the Municipal Government of Bulalacao for the effective and efficient use of the area for the benefits of all; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Regional Director, Bureau of Fisheries and Aquatic Resources, Region IV to immediately conduct ocular inspection and

investigation on the 59 hectares of Fishpond Lease Agreement situated at Sitio Tabok, Barangay Poblacion, Bulalacao, Oriental Mindoro;
