EARNESTLY REQUESTING THE HONORABLE BARTOLOME L. MARASIGAN, PROVINCIAL GOVERNOR, PROVINCE OF ORIENTAL MINDORO TO EXTEND ASSISTANCE TO THE MUNICIPALITY OF BULALACAO IN ITS CAMPAIGN AGAINST ILLEGAL LOTENG

"WHEREAS, the proliferation of illegal gambling notably "loteng" erode our peoples strength and values as a nation. Its continuous operation is a menace that destroys the moral fiber of our society;

"WHEREAS, loteng degrades the sincerity and credibility of the local officials to serve and protect its people against social and economic losses for they are mistaken to be the protector of this illegal act;

"WHEREAS, it is sadly observed that inspite of several Memorandum Orders issued to the Bulalacao PNP Station directing them to conduct massive and serious battle against loteng still it continues to operate at this Municipality to the detriment of the ordinary residents who depend their future in the guise of hope rather than to sheer hardwork;
