“RESOLUTION NO. 00-10-151

RESOLUTION ENDORSING SENATE BILL 1935 ENTITLED “AN ACT
INCREASING THE BENEFITS AND INCENTIVES TO BARANGAY
OFFICIALS AND FOR OTHER PURPOSES”

WHEREAS, in recognition to the vital function of the Barangay Officials in the affairs of the Local Government Unit where they belong and to the nation as a whole in the delivery of quality basic services to the people, Senator Juan M. Flavio introduced Senate Bill 1935 entitled “An Act Increasing the Benefits and Incentives to Barangay Officials and for Other Purposes”;

“WHEREAS, this Act which shall be known as the “Magna Carta” for Barangay Officials sought to give additional benefits such as hazard allowance, subsistence allowance, free legal services, preferential access to loans, clothing allowance, communication equipment acquisition, motorcycle plan, and other benefits,

“WHEREAS, the passage of Senate Bill 1935 is believed to benefit thousands of barangay officials nationwide who for so many years were denied of these privileges inspite of their strong will and dedication to duty,


