EARNESTLY REQUESTING THE HONORABLE RODOLFO G. VALENCIA, PROVINCIAL GOVERNOR AND CHAIRMAN OF THE PROVINCIAL SCHOOL BOARD TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF WATER RESERVOIR AND SANITARY TOILET AT MAUJAO NATIONAL HIGH SCHOOL AT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, by virtue of House Bill No. 9594, the Maujao National High School at Barangay Maujao, Bulalacao, Oriental Mindoro was established that shall caters the students coming from five (5) adjacent barangays;

"WHEREAS, the schoolbuilding was constructed last year but due to insufficiency of funds it still lacks the necessary amenities and facilities such as the water reservoir and a sanitary toilet;

"WHEREAS, the Maujao National High School is expected to open next School Year that there is a need to provide the students and teachers with the abovementioned school amenities;


