RESOLUTION NO. 04-11-143

ADOPTING THE POLICY OF HOLDING THE REGULAR SESSION OF THE SANGGUNIANG BAYAN AT THE BARANGAY AT LEAST TWICE A MONTH

"WHEREAS, cognizant with the possible positive benefits this Sangguniang Bayan decided to conduct two regular session at its chosen barangay every month, and likewise to have periodic consultation with appropriate barangay officials, non-government and people organization, and other concern sectors of the community before any project or program is implemented in their respective jurisdiction,

"WHEREAS, it is with deeper understanding that this decision has been made in order to pursue the principle of Local autonomy which means to be a process of decentralization from the National Government to the lowest LGU without any intermedial. However it is likewise encouraged under the Local Government Code of 1991, a productive and mutual inter-governmental relation between Local Government Units,

"WHEREAS, with this kind of program the Sangguniang Bayan will be able to explore the relationship, similarities and differences and needs of potential and heritage including the social function, areas of concern and avenues for cooperation between and among the Municipal Government and all the component barangays. Thus in so doing the local legislators could best appreciate and be familiar with the entire socio-economic, political, cultural records continuum and there application into that grant effort to designed and implement governmental projects and programs designed to implement the basic principle of sustainable development, and people empowerment; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, TO: Adopt the policy of the regular session of the Sanggunian at the Barangay at least twice a year.


