"WHEREAS, education is essential to national building as acknowledged by Section 17, Article II in the Declaration of State Policies of the 1987 Constitution;

"WHEREAS, it is mandated that basic education be made accessible to all Filipinos;

"WHEREAS, it is perplexing and disturbing, however, that we are long way from spreading the benefits of basic education to the great majority of our countrymen, especially those in far-off rural areas as reported by the Congressional Commission on Education (EDCOM) in 1991;

"WHEREAS, as an example, many children who are of school age at Sitio Bating, Barangay Milagrosa, this Municipality, have to walk several kilometers in order to get elementary education;
