FORESTAL LAND CO-EXISTENT WITH THE CANCELLED FISHPOND
LEASE AGREEMENT PREVIOUSLY GRANTED IN FAVOR OF CERTAIN

"WHEREAS, among the important powers that is lodge in the Municipality is
the power to protect the environment relating particularly to the conservation of
mangrove resources, the establishment of parks, green belts in accordance with
Section 17, par (ii) of RA 7160;

"WHEREAS, it is noteworthy that the specific provision of the Local Code
devolving from the central government the enforcement of fishery laws in the
municipal waters and also encourages the Local Government Units to establish
park, greenbelts and other forest development projects; thus there shall be a
great probability that we will minimize the despoliation of mangrove resources,
and that the greening of the countryside may be more speedily accomplished;

"WHEREAS, it cannot be gainsaid the positive effects of a healthy
mangrove resources in maintaining and preserving a balanced ecology, as
various scientific studies pointed out that mangrove status is an excellent
barometer in gauging environmental condition;

"WHEREAS, our intention to administer the cancelled Fishpond Lease Agreement (FLA), (containing an area of 96 hectares) granted by the Department of Agriculture to Mr. Arnulfo Sison was conveyed thru our SB Resolution No. 03-01-015, (copy of which is hereby attached), and was duly acted upon by the National Director Malcolm Sarmiento, Jr. of BFAR-Region -IV, admising that any proponent wishing to utilize areas already released exclusively to the Forest Management Bureau other than the fishpond purpose must be addressed to the DENR which will recommend to the President of the Republic of the Philippines, the designation of the area for the purpose usage thru a Presidential Proclamation, stressing further that only DENR and the President can dispose or alienate forest land;


