**AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ATTY. EDGARDO C. ACERON ENGAGING THE SERVICES OF THE LATTER AS LEGAL COUNSEL IN CIVIL CASE NO. 255 ENTITLED "RODOLFO V. DAYANGHIRANG, ET AL VERSUS THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO AND OTHER RELATED CASES"**

"WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro was sued under Civil Case No. 255 by Rodolfo V. Dayanghirang and Nenita Yang for Forcible Entry and Damages with Temporary Restraining Order and/or Preliminary Mandatory Injunction;


"WHEREAS, this case was filed by the abovementioned plaintiffs when the Municipal Government of Bulalacao, Oriental Mindoro started to construct a public market at Barangay Campaasan to which the lot is claimed by both the Rodolfo V. Dayanghirang, Nenita Yang and the Municipal Government;


"WHEREAS, the hiring of atty. Edgardo C. Aceron as legal Counsel is provided for by law which says that a government agency or entity being sued shall be represented by a government lawyer; Atty. Aceron is at present the Provincial Legal Consultant; Now, therefore, be it


