SPECIAL ORDINANCE NO. 08-09-100

LUMEL CABAGAY GRANTING THE LATTER THE AUTHORITY TO IMPLEMENT THE CONSTRUCTION OF THE NATIONAL HIGHWAY (TUKLONG) TO SITIO POCANIL, BARANGAY SAN ROQUE, BULALACAO, ORIENTAL MINDORO




