


**"WHEREAS**, Governor Panaligan is noted for his concern on the plight of the poor so that this request will surely merit his preferential attention; Now, therefore, be it



ON MOTION of Councilor Eric Michael R. Pajotal duly seconded by Councilor Gabriel C. Hermilao, foregoing was . . .






