RESOLUTION NO. 07-08-064

EARNESTLY REQUESTING THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICER (CENRO) TO FACILITATE URGENT ACTION ON THE APPLICATION FOR SPECIAL PATENT ON VARIOUS PARCELS OF LAND OCCUPIED AND OWNED BY THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Department of Environment and Natural Resources, through its field offices such as CENRO is one of the agencies that is tasked to facilitate the titling of any landholdings;

"WHEREAS, the ownership of ten (10) parcels of land declared in the name of the Municipality of Bulalacao were not evidenced by Torrens Title as required by the law and other offices such as Commission on Audit, or any other substantial and/or satisfactory documents to prove ownership thereof;

"WHEREAS, the Municipality is hounded by deep apprehension that the present situation may invite other interested parties including squatters to claim the right to subject landholdings which the Municipality considered to be belonging to it;

"WHEREAS, the Office of the Municipal Mayor working closely with the Office of the Municipal Assessor officially requested CENRO, San Mariano, Roxas, Oriental Mindoro for assistance in the immediate titling of landholdings declared on its favor, in fact necessary documents required in the application for title were already forwarded to that Office however, the bottleneck was also found there for it failed to transmit all submitted documents to the higher offices for reasons unknown to us;


"WHEREAS, already alarmed by the threat of possible encroachment the problem of the absence of title for our landholdings was compounded by the failure of the CENRO to positively and promptly act on the request of this Municipality for assistance in hastening up the titling of municipal real properties, Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Community Environment and Natural Resources Office, San Mariano, Roxas, Oriental Mindoro to facilitate urgent action on the application for special patent on various parcels of land occupied and owned by the Municipal Government of Bulalacao;
