RESOLUTION NO. 09-06-080

RESOLUTION INTERPOSING OBJECTION TO THE ISSUANCE OF TITLE TO PRIVATE PERSONS OR CORPORATIONS APPLYING FOR OWNERSHIP OF THE FOLLOWING ISLETS NAMELY: BANGGASU, SILAD, KARAMBINGAN AND INCLUDING PASTURE LANDS UNDER THE PASTURE LAND AGREEMENT ISSUED TO MADECO

“WHEREAS, in an effort to invite more tourists to the country, who, through their spending help increase the country’s foreign exchange earnings and; to generate maximum employment opportunities for Filipinos in tourism-oriented establishments and projects, Malacanang has declared under Proclamation No. 1801, Tourist Reserves in the Municipality of Bulalacao, Province of Oriental Mindoro;

“WHEREAS, the Local Government of Bulalacao having the power to discharge some functions and responsibilities of National Agencies pursuant to the Local Government Code of 1991 is proposing that will be allowed to enter into a Co-Management Agreement with the Department of Environment and Natural Resources in utilizing the Pasture Lands within the Municipality particularly that lands under the Pasture Land Agreement issued to MADECO, and various islets namely: Banggasu, Silad and Karambingan; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Interpose objection to the issuance of Title to private persons or corporations applying for ownership of the following islets namely: *Banggasu, Silad, Karambingan* and including Pasture Lands under the Pasture Land Agreement issued to MADECO;

RESOLVED FURTHER, To: Let copies of this resolution be furnished the Office of the President, Malacanang Palace, Manila, the Secretary of the Department of Environment and Natural Resources (DENR), 2/F DENR Bldg., Visayas Avenue, Quezon City, the Provincial Agrarian Reform Office, Calapan City and the Community Environment and Natural Resources Office, San Mariano, Roxas, Oriental Mindoro, for their information and appropriate action;




