RESOLUTION NO. 11-01-023

SUPPORTING AND INDORSING H.B. NO. 3116 FILED BY CONGRESSMAN ISIDRO S. RODRIGUEZ, JR. CONFERRING THE APPROPRIATE CIVIL SERVICE ELIGIBILITY UPON MEMBER OF THE SANGGUNIANG BAYAN, SANGGUNIANG PANLUNGSOD AND SANGGUNIANG PANLALAWIGAN WHO HAS SERVED FOR AT LEAST THREE (3) CONSECUTIVE TERMS IN OFFICE

"WHEREAS, Congressman Isidro S. Rodriguez, Jr. filed H.B. No. 3116 before the House of Representatives with the end in view of passing a law conferring appropriate civil service eligibility upon member of any of the various sanggunians of local government units, (aside from the sangguniang barangay who already enjoys the sought benefit) who has served for at least three (3) consecutive terms in office;

"WHEREAS, leafing through the pages of RA7160, otherwise known as the Local Government Code of 1991, and with the cursory look to Paragraphs 5 (b) of Section 393, provides that the punong barangay, the barangay treasurer and barangay secretary shall be entitled to appropriate civil service eligibility on the basis of the number of years to the barangay pursuant to the rules and regulations issued by the Civil Service Commission (CSC);

"WHEREAS, this sangguniang bayan believes that out-going sanggunian members with their experience, knowledge and skills honed through years of government service can still motivate, encourage and maximize their capability to contribute to nation building and better governance in touch with the aspirations and needs of the community they once served as elective officials;

"WHEREAS, it is firmly believed that the benefits conferred upon barangay officials as spelled-out in the above-quoted provision of the law deserves to be extended to the member of the sangguniang bayan, panglalawigan or panglungsod who has served for at least 3 consecutive terms; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Support and Indorse H.B. No. 3116 filed by Congressman Isidro S. Rodriguez, Jr. conferring the appropriate Civil Service Eligibility upon member of the Sangguniang Bayan, Sangguniang Panglungsod and Sangguniang Panlalawigan who has served for at least three (3) consecutive terms in office;






