RESOLUTION NO. 10-03-030

REQUESTING THE PROVINCIAL AGRARIAN REFORM OFFICE, CALAPAN CITY TO EXPEDITE THE IMMEDIATE ISSUANCE OF CLEARANCE TO FACILITATE THE TRANSFER OF TITLE NO. T-146 806, LOT NOS. 4 AND 6 SITUATED IN BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO IN THE NAME OF THE MUNICIPAL GOVERNMENT OF BULALACAO, THIS PROVINCE

"WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro has acquired two (2) parcels of lot situated in Barangay Poblacion, Bulalacao, Oriental Mindoro from the Philippine Veterans Bank to be used as the expansion site for the public cemetery by way of purchase/sale;

"WHEREAS, that said parcel of Lot Nos. 4 and 6 with the total land area of 63,039 sq.m. were previously titled under the ownership of the Philippine Veterans Bank that the Municipal Government of Bulalacao is working for the transfer of the title on its favor, nonetheless a DAR certification or clearance for the transfer or issuance of a new title thereof is a requirement imposed bylaw;

"WHEREAS, it is the desire of the Municipal Government to have all its real properties property documented to establish validity and legality for its dominion and usage of those properties to avoid any future possible conflict over ownership that might arise; Now, therefore, be it,

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Provincial Agrarian Reform Office, Calapan City to expedite the immediate issuance of clearance to facilitate the transfer of Title No. T-146 806, Lot Los. 4 and 6 situated in Barangay Poblacion, Bulalacao, Oriental Mindoro in the name of the Municipal Government of Bulalacao, this Province;

RESOLVED FURTHER, To: Let copy of this resolution be furnished Mr. Danilo Fortaleza, Officer-In-Charge, Municipal Agrarian Reform Officer, Bulalacao, Oriental Mindoro for his information, reference and appropriate action;
