"WHEREAS, pursuant to Republic Act No. 4136 also known as Land Transportation and Traffic Code, Section 5 (a), the Compulsory Registration of Motor Vehicles states that all motor vehicles and trailer of any type used or operated on or upon any highway of the Philippines must be registered with Bureau of Land Transportation for the current year in accordance with the provisions of this act;

"WHEREAS, Bulalacao, despite to being a 3rd class municipality and located at the southernmost tip of the Province of Oriental Mindoro is well-nigh to having all its roadways concreted and accessible to all types of vehicles, hence, the number of residents having their own vehicle are continuously increasing;

"WHEREAS, there has been an increased volume of vehicles in Bulalacao which prompted for the vehicle owners to ensure that they should register their vehicles, for this reason, it would need an amount of money to process documents and other requirements and it would be hassle travelling to any extension offices of LTO adjacent to this municipality;


