### RESOLUTION NO. 10-03-032

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2010 OF BARANGAY MAASIN, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF SEVEN HUNDRED SIXTY ONE THOUSAND TWENTY ONE PESOS AND TWENTY TWO CENTAVOS (PHP761,021.22) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 2010-01 DATED JANUARY 4, 2010

“WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

“WHEREAS, the Sangguniang Barangay of Maasin, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2010 showing therein the sources of income and barangay expenditures starting from January 1, 2010 up to December 31, 2010;



“WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing COA rules and regulations, Now, therefore, be it;


