RESOLUTION NO. 21-07-216

RESOLUTION RECOGNIZING AND COMMENDING THE BULALACAO COMMUNITY HOSPITAL IN BULALACAO, ORIENTAL MINDORO FOR BEING THE DEPARTMENT OF HEALTH CERTIFIED LIGTAS COVID-19 COMMUNITY ISOLATION UNIT (LCCIU) AND FOR HAVING ITS COMMUNITY ISOLATION UNIT (CIU) THE ACCREDITATION FROM PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) AS A PROVIDER OF COVID-19 COMMUNITY ISOLATION BENEFIT PACKAGE (CCIBP)

"WHEREAS, pursuant to the 1987 Constitution, the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged, sick, elderly, disabled, women and children. The state shall endeavor to provide free medical care to paupers;

"WHEREAS, Bulalacao is a 3rd class Municipality hounded with financial constraints located at the southernmost tip of the Province of Oriental Mindoro, has a population of 39, 107 based on 2015 census, 25 percent of which are indigenous people called Hanunuo Mangyan, has a municipal government that uplift the general health condition of the people;

"WHEREAS, the Bulalacao Community Hospital is the only hospital in the municipality that caters immediate medical needs and emergencies to its people;

"WHEREAS, it is evident that the cases of COVID 19 in the municipality of Bulalacao is continuously increasing that the provision of community isolation benefit package is very much needed;

"WHEREAS, the Bulalacao Community Hospital complied to the requirements of the Department of Health that made it a certified Ligtas COVID-19 Community Isolation Unit (LCCIU), afterwards its Community Isolation Unit (CIU) had been accredited by PhilHealth as a provider of COVID-19 Community Isolation Benefit Package (CCIBP) that would be beneficial for the COVID-19 patients of this municipality;

"WHEREAS, this Sanggunian recognizes and commends the achievement of the Bulalacao Community Hospital in providing efficient medical services to Bulalacao more importantly the availability of treatments for COVID-19 cases; Now, therefore, be it.....
