RESOLUTION EXPRESSING THANKS AND GRATITUDE TO THE DEPARTMENT OF HEALTH-MIMAROPA FOR CERTIFYING THE BULALACAO COMMUNITY HOSPITAL IN BULALACAO, ORIENTAL MINDORO AS LIGTAS COVID -19 COMMUNITY ISOLATION UNIT (LCCIU) AND FOR HAVING ITS COMMUNITY ISOLATION UNIT(CIU) THE ACCREDITATION FROM PHILIPPINE HEALTH INSURANCE CORPORATION AS PROVIDER OF COVID-19 COMMUNITY ISOLATION BENEFIT PACKAGE (CCIBP)

“WHEREAS, pursuant to the 1987 Constitution, the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged, sick, elderly, disabled, women and children. The state shall endeavor to provide free medical care to paupers;

“WHEREAS, Bulalacao is a 3rd class Municipality hounded with financial constraints located at the southernmost tip of the Province of Oriental Mindoro, has a population of 39, 107 based on 2015 census, 25 percent of which are indigenous people called Hanunuo Mangyan, has a municipal government that uplift the general health condition of the people;

“WHEREAS, the Bulalacao Community Hospital is the only hospital in the municipality that caters immediate medical needs and emergencies to its people;

“WHEREAS, in this COVID-19 pandemic, it is important for every municipality to have an isolation unit that would aid and confine COVID-19 patients, auspiciously the Bulalacao Community Hospital received a Ligtas COVID-19 Community Isolation Unit (LCCIU) certification from Department of Health that is a pre-requisite to COVID-19 Community Isolation Benefit Package (CCIBP);

“WHEREAS, the Local Government Unit of Bulalacao is grateful to the Department of Health-MIMAROPA for giving a certification of Ligas COVID-19 Community Isolation Unit (LCCIU) certification to Bulalacao Community Hospital that would help certainly the COVID-19 patients of this municipality; Now, therefore, be it.....
