Faner engaging the services of the latter as Senior Administrative Assistant assigned in the Office of the Municipal Mayor in consideration of a monthly rate of forty thousand pesos (PhP40,000.00) as wage for services rendered subject to a "No Work, No Pay" rule which shall take effect on January 3, 2023 until December 31, 2023;






