RESOLUTION REQUESTING THE DEPARTMENT OF ENERGY THRU SECRETARY ALFONSO G. CUSI TO ENHANCE AND UPGRADE THE POWER SUPPLY AND ELECTRIFICATION SERVICE IN THE PROVINCE OF ORIENTAL MINDORO PARTICULARLY IN THE MUNICIPALITY OF BULALACAO

“WHEREAS, the Department of Energy is the executive department of the Philippine government responsible for preparing, integrating, manipulating, organizing, coordinating, supervising and controlling all plans, programs, projects and activities of the Government relative to energy exploration, development, utilization, distribution and conservation;

“WHEREAS, for over the past decades, our Government has always been prioritizing the rural electrification, it strongly believes that the provision of electric services will produce more opportunities to improve the socio-economic growth of the marginalized sectors, and it will have a greater access to basic services and better infrastructure for rural development;

“WHEREAS, Bulalacao is a third class Municipality located at the southernmost tip of the Province of Oriental Mindoro, it has a Municipal Government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

“WHEREAS, the Oriental Mindoro Electric Cooperative, Inc. (ORMECO) is the only electric distribution cooperative which gives power distribution in the entire province of Oriental Mindoro, however there are reports that it has been giving undersupply power and poor service especially in the municipality of Bulalacao; Now, therefore, be it...






