**URGING THE PROVINCIAL GOVERNMENT THROUGH THE PROVINCIAL HEALTH OFFICER TO STOP THE USUAL PRACTICE OF TEN DAY CONSECUTIVE WORK IN A MONTH BY MEDICAL DOCTORS ASSIGNED OR DETAILED IN BULALACAO COMMUNITY HOSPITAL, BULALACAO, ORIENTAL MINDORO**

**“WHEREAS**, promotion of health is one of the frontline services of every local government unit that must be delivered to its constituents;

**“WHEREAS**, through health centers and public hospitals, this basic State responsibility is done particularly by the province-run district hospital in the Municipality of Bulalacao, Oriental Mindoro whose patients come from the lowest of the socio-economic strata of the society;

**“WHEREAS**, it is observed that the present set-up of letting medical doctors to render 10 consecutive, no let-up working days for a month and let them to have the rest of the working days to rest proved to be counter-productive and in fact elicited negative remarks and comments from the clientele they are bound to serve;

**“WHEREAS**, in order to correct and address properly the complaints heard and accede to the more popular public opinion, this sangguniang bayan recommends that applicable Civil Service Rules and Regulations regarding this matter be religiously applied; Now, therefore, be it


