### RESOLUTION NO. 13-07-062

**A RESOLUTION APPROVING THE APPROPRIATION FOR THE TOTAL SUBPROJECT COST RELATIVE TO THE IMPLEMENTATION OF SUBPROJECT, IMPROVEMENT OF CAMBUNANG COMMUNAL IRRIGATION PROJECT FINANCED BY THE AGRARIAN REFORM COMMUNITIES II (ARCP II) IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

“**WHEREAS**, the Agrarian Reform Communities Project II (ARCP II) is a six-year development project of the Department of Agrarian Reform (DAR) financed by a loan from the Asian Development Bank under Loan no. 2465-PHI and OPEC Fund for International Development (OFID) under Loan no. 1225P

“**WHEREAS**, the ARCP II shall fund development activities in selected Agrarian Reform Communities (ARCs) and ARC clusters in Southern Philippines in partnership with Local Government Units;

“**WHEREAS**, the ARC of Cambunang located in the Municipality of Bulalacao, Province of Oriental Mindoro became one of the selected beneficiaries of the ARCP II through the subproject, **Improvement of Cambunang Communal Irrigation Project**;

“**WHEREAS**, the MDFO of the Department of Finance (DOF) shall serve as the agency-conduit for channeling the ARCP II loan proceeds to LGU-beneficiaries in implementing the proposed subprojects under ARCP II.

"WHEREAS, the total Subproject Cost in the amount of **Twenty Million Pesos (Php 20M)** under the ARCP II has to be appropriated to provide an authority for the LGU to disburse the funds for the implementation of the proposed subproject in accordance with the following financing mix:

ARCP II Loan Proceeds (Grant) - PhP 10M  
LGU Equity - PhP 5M  
NGALGU - PhP 5M

**RESOLVED AS IT IS HEREBY RESOLVED**, this body has approved the "Appropriation of the Total Subproject Cost" amounting to Twenty million pesos (Php 20M) under the ARCP II of the DAR broken down as follows:

Loan Proceeds (Grant) - 50% -- PhP 10M  
LGU Equity - 25% -- PhP 5M  
NGALGU - 25% - PhP 5M

**RESOLVED FURTHER**, To grant authority to the Municipal Treasurer in disbursing the above appropriation subject to usual accounting and auditing procedures, rules and regulations and in accordance with existing and applicable laws;

**RESOLVED FINALLY**, To furnish copies hereof, Honorable Municipal Mayor Edna C. Villas, this LGU, DAR and all others concerned for their information and appropriate action.
