It shall ensure the proper use of these resources and the protection of environment within the framework of sustainable development;

**"WHEREAS**, the Forest Management Bureau of the Department of Environment and Natural Resources provides support for the effective protection, development, occupancy, management and conservation of forest lands and water sheds;

"WHEREAS, with the co-management agreement with the DENR through CENRO, the Department of Environment and Natural Resources shall coordinate, guide and train the LGU in the management of the devolved functions. As the LGUs' capacity in forest management is enhanced, the primary tasks in the management of devolved functions shall be performed by the LGUs and the role of the DENR becomes assistance and coordinative;


