### **RESOLUTION NO. 20-10-449**

**EARNESTLY REQUESTING THE REGIONAL DEVELOPMENT COUNCIL TO  
PRIORITIZE THE APPROPRIATION OF NECESSARY FUNDS FOR THE  
CONSTRUCTION OF FLOOD MITIGATION CONTROL PROJECT THAT  
WOULD ADDRESS THE PERENNIAL FLOODING IN BARANGAYS  
CAMBUNANG, CAMPAASAN AND NASUCOB, ALL OF THE MUNICIPALITY  
OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**“WHEREAS**, floods have large social consequences for communities and individuals as most are well aware. The immediate impact of flooding include loss of human life, damage to property, destruction of crops, loss of livestock and deterioration of health condition's owing to waterborne diseases;

**“WHEREAS**, in agriculture, flood continue to induce damages in plants which resulted to yield losses. Flooding not only weakens plant defenses but the soil and water conditions prevalent during flooding favor the development of many plant pathogens so crops suffer increased disease problems after floods;

**“WHEREAS**, for so many years, Barangays Cambunang, Campaasan and Nasucob of the Municipality of Bulalacao, Province of Oriental Mindoro suffer flooding brought by heavy rains during the occurrence of typhoon which resulted to large volume of agricultural damage and losses taking into consideration that all these three barangays are vast agricultural land engaged into planting of rice, corn, garlic, onions and different varieties of vegetables;

**“WHEREAS**, since flooding is brought by the onslaught of bad weather condition which nobody can control, the best mitigating approach is the construction of a flood control structure on large rivers like the Cawacat River in Barangay Cambunang, this Municipality;

**"WHEREAS**, Cawacat Junction is connecting the three barangays mentioned above and is the major thoroughfare between the Provinces of Oriental and Occidental Mindoro that transportation in the area is hampered when flooding occurs;

**"WHEREAS**, for lifetime use and purposes, there is a need for the construction of a flood mitigation control project that would address flooding that brought both social and economic losses for the people and the community as a whole; **Now, therefore, be it**


**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request the Regional Development Council to prioritize the appropriation of necessary funds for the construction of flood mitigation control project that would address the perennial flooding in Barangays Cambunang, Campaasan and Nasucob, all of the Municipality of Bulalacao, Province of Oriental Mindoro;


