EARNESTLY REQUESTING THE PROVINCIAL GOVERNOR HUMERLITO "BONZ" A. DOLOR TO ALLOCATE THE AMOUNT OF FIVE MILLION PESOS (PhP5M) TO BE USED FOR THE REHABILITATION AND CONSTRUCTION OF TABUK HANGING BRIDGE IN SITIO TABUK, BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO

WHEREAS, Sitio Tabuk Hanging Bridge connects Sitio Tabuk to mainland of Barangay Poblacion, Bulalacao is the only passage of residents going to and vice versa to the town proper;

WHEREAS, recently, the hanging bridge collapsed which caused slight injury to the children and residents including the parist priest, Fr. Allan Fallaria who was on his way home from a mass he celebrated in honor of the feast of patron saints, Sts. Peter and Paul on June 27, 2022;

WHEREAS, the repair of the hanging bridge has an initial fund of PhP1.9M from the Provincial Government which according to the evaluation and assessment conducted by the Provincial Planning and Development Office (PPDO), it needs an additional of PhP5M to complete the construction for the safety and convenience of the residents thereat;


