EARNESTLY REQUESTING THE DEPARTMENT OF HEALTH THRU SECRETARY PAULYN JEAN B. ROSELL-UBIAL AND THE DEPARTMENT OF HEALTH, REGIONAL OFFICE TO GRANT ONE (1) UNIT OF 20-FOOTER FIBER GLASS SPEED BOAT SEA AMBULANCE TO THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, located in the southernmost tip of the Province of Oriental Mindoro, is composed of eight (8) coastal barangays whose residents depend on fishing for a living;

"WHEREAS, residents from the coastal barangays need to travel one (1) to two (2) hours by sea going to town proper to do everyday business, and as such, heavy and violent waves threatens their lives particularly during inclement weather;

"WHEREAS, in addition to this hazardous situation, occurrence of medical emergencies endanger life even more, because patients should be brought to the nearest hospital in town for immediate medical care, thus a speed boat sea ambulance with complete first aid facilities is direly needed; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Department of Health thru Secretary Paulyn Jean B. Rosell-Ubial and the Department of Health, Regional Office to grant one (1) unit of 20-footer fiber glass speed boat sea ambulance to the Local Government Unit of Bulalacao, Oriental Mindoro;




