### RESOLUTION NO. 21-03-100

**RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) THRU SECRETARY MARK A. VILLAR TO ALLOCATE FUND FOR THE IMPLEMENTATION OF VARIOUS INFRASTRUCTURE PROJECTS THAT WILL PROMOTE TOURISM AND ECONOMIC DEVELOPMENT IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**“WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

**“WHEREAS**, the Municipality of Bulalacao is a third class municipality located at the southernmost tip of the Province of Oriental Mindoro that has a distinct geographical features with a population of 39, 107 based on 2015 census, 25 percent of which are indigenous people called Hanunuo Mangyan;

**“WHEREAS**, Bulalacao is well-nigh to being an agro-eco-tourism destination in the Province of Oriental Mindoro, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

**“WHEREAS**, the Local Government of Bulalacao is focus and steadfast in improving the tourism and economic status of the municipality as a whole by doing infrastructure projects that are beneficial to its people;

**“WHEREAS**, the various proposed infrastructure projects intended for the promotion of tourism and economic development of the Municipality of Bulalacao, Province of Oriental Mindoro are the following herein, to wit:

- i. Concreting of Gatol-Agong-Banti local access road in the amount of PhP95,000,000.00.
- ii. Concreting of Baggao-Talibog local access road in the amount of PhP50,000,000.00.
- iii. Opening/Concreting of Bating-Hinagdanan local access road in the amount of PhP95,000,000.00.
- iv. Opening/Concreting of Hinagdanan-Burungkaan local access in the amount of PhP95,000,000.00
- v. Concreting of Imbuyungan-Kalong-Dacutan local access road in the amount of PhP50,000,000.00.
- vi. Concreting of San Juan-Quipanglaw-Tambangan local access road in the amount of PhP95,000,000.00.
- vii. Opening/Concreting of Suryawan-Lagnas-Gatol local access road in the amount of PhP50,000,000.00.
- viii. Opening/Concreting of Quipanglaw-Bugticol-Bangkal local access road in the amount of PhP50,000,000.00.
- ix. Cavillian River Control Project in the amount of PhP98,000,000.00.
- x. Construction of Sea Wall Poblacion, Bulalacao, Oriental Mindoro in the amount of PhP135,000,000.00.

“WHEREAS, the allocation of funds from DPWH would certainly support and help the fulfillment of the aforementioned various infrastructure projects that will uphold structural integrity of public facilities and utilities of the said municipality;
