REQUESTING THE HONORABLE REYNALDO V. UMALI, CONGRESSMAN, 2ND DISTRICT, PROVINCE OF ORIENTAL MINDORO TO FACILITATE THE PASSAGE OF A BILL GRANTING CIVIL SERVICE ELIGIBILITY TO ALL 3-TERM ELECTIVE PUBLIC OFFICIALS AND CO-TERMINOUS EMPLOYEES WHO HAVE RENDERED PUBLIC SERVICE FOR AT LEAST 9 CONSECUTIVE YEARS

“WHEREAS, Republic Act No. 10156 the “Act Conferring upon members of the Sangguniang Bayan, Sangguniang Panglunsod and Sangguniang Panlalawigan, the appropriate civil service eligibility under certain circumstances, and for other purposes” is now in effect following the issuance of the IRR covering the Sangguniang Bayan Eligibility (SBE) by the Civil Service Commission;

“WHEREAS, Republic Act No. 10156 is strictly referring to local legislators only that taking into consideration the role of the local executives in ensuring the best delivery of basic social services to its constituents such as the Municipal Mayor, the Municipal Vice Mayor among others including their confidential staff who are co-terminous in nature, this August Body takes the initiative to recognize their valuable efforts and services that appropriate CSC Eligibility shall be granted unto them; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Honorable Reynaldo V. Umali, Congressman, 2nd District, Province of Oriental Mindoro to facilitate the passage of a bill granting civil service eligibility to all 3-term elective public officials and co-terminous employees who have rendered public service for at least 9 consecutive years;


