RESOLUTION NO. 20-06-321

REQUESTING MR. GREIO M. ELAYDO, PROVINCIAL FISHERY OFFICER, PROVINCE OF ORIENTAL MINDORO TO CONDUCT MUNICIPAL FISHERFOLK REGISTRATION IN THE MUNICIPALITY OF BULALACAO, THIS PROVINCE

"WHEREAS, the registration of fisherfolk under the Municipal Fisherfolk Registration Program (Fish R) boosted the government's ability to extend health care and insurance to the fishing sector. Likewise, this is done in pursuance to the mandate of the Philippine Fisheries Code of 1998 which mandates the government to have a complete registry of municipal fisherfolk;

"WHEREAS, a registered fisherfolk living below the poverty line will receive free health care coverage and the insurance will cover fishing boats, seaweeds, fish cages, fish ponds and other agricultural stocks and aquaculture facilities damaged by calamity;


"WHEREAS, the fisherman registration made several months ago was not completely done for there are still fisherfolks left unregistered that taking into consideration of the social and economic benefits from being registered, the Provincial Fishery Office is earnestly requested to conduct another fisherman registration at this Municipality; **Now, therefore, be it**


RESOLVED AS IT IS HEREBY RESOLVED, To: Request Mr. Greio M. Elaydo, Provincial Fishery Officer, Province of Oriental Mindoro to conduct municipal fisherfolk registration in the Municipality of Bulalacao, this Province;
