**RESOLUTION REQUESTING THE MALAMPAYA FOUNDATION INC. (MFI)
TO GRANT ONE (1) UNIT OF PATROL BOAT TO EACH OF EIGHT (8)
COASTAL BARANGAYS OF BULALACAO, ORIENTAL MINDORO**

"WHEREAS, Malampaya Foundation Inc. (MFI) works with communities and other organizations to help conserve the rich and diverse marine ecosystems found in its focal areas in Batangas City, Eastern Mindoro and Northern Palawan, areas classified as marine biodiversity hotspots;

"WHEREAS, Bulalacao, a third class municipality located at the southernmost tip of the province, has 8 coastal barangays out of 15, and is enclosed by Bulalacao Bay and Tablas Strait;

"WHEREAS, this strategically located municipality is acclaimed as the fishing capital of Oriental Mindoro transporting large volume of fish and marine products to nearby provinces and Metro Manila;

"WHEREAS, being a coastal municipality, it is challenged to protect its seas from over and illegal fishing, use of noxious chemical, dynamite, and other unlawful means that would degrade, endanger, and deteriorate marine environment and resources;

"WHEREAS, the barangay governments and the LGU of Bulalacao jointly established Bantay Dagat Task Force and Barangay Fishery and Aquatic Resources Management Council which are responsible in protecting the municipal seas from unscrupulous and irresponsible individuals or groups, and it would be favorable for them to have patrol boats to facilitate the performance of such function;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to request the Malampaya Foundation Inc. to grant 1 unit of patrol boats to each of 8 coastal barangays of Bulalacao, Oriental Mindoro.
