RESOLUTION NO. 17-10-231

EXPRESSING UNWAVERING SUPPORT TO FORMER MAYOR EDNA C. VILLAS AND INCUMBENT MAYOR ERNILO C. VILLAS, BOTH OF BULALACAO, ORIENTAL MINDORO, IN RELATION WITH THE CASES FILED AGAINST THEM BEFORE THE OFFICE OF THE OMBUDSMAN ENTITLED "ROMUEL D. ATIENZA VERSUS EDNA C. VILLAS, ET. AL WITH DOCKET NUMBER OMB-L-C-17-0433 FOR: RPC ART. 282 – GRAVE THREATS: R.A. 3019 SEC. 3 (E)& (J) AND ROMUEL D. ATIENZA VERSUS EDNA C. VILLAS, ET. AL WITH DOCKET NUMBER OMB-L-A-17-0469 FOR: GRAVE MISCONDUCT"

"WHEREAS, pursuant to Sec. 5, par. a of the Local Government Code of 1991 "Any provision on a power of a local government unit shall be liberally interpreted in its favor, and in case of doubt, any question thereon shall be resolved in favor of devolution of powers and of the lower government unit. Any fair and reasonable doubt as to the existence of the power shall be interpreted in favor of the local government unit concerned";

"WHEREAS, the issue arises when Romuel D. Atienza served the Revocation of Donation with Special Power of Attorney on April 3, 2013 to the Office of the Municipal Mayor and the Office of the Sangguniang Bayan claiming that the Deed of Donation made by his father, Aniceto Atienza to the Bureau of Plant Industry (BPI) of the two (2) hectares of his land situated in Barangay Nasucob, Bulalacao, Oriental Mindoro be reverted back to them for reason that the BPI is no longer using the donated lot;

"WHEREAS, at present, the lot where the Agricultural Center and Breeding Station (AC/BS) is situated serves as an extension and on-site center and facilities related to agriculture and fishery activities which include dispersal of livestock and poultry and other seedling materials for aquaculture, palay, corn and vegetable seed farms, medicinal plant gardens, fruit trees, coconut and other kinds of seedling nurseries, demonstration farm and other community-based forestry projects;

"WHEREAS, taking into account that the Bureau of Plant Industry is under the umbrella of the Department of Agriculture which continues to extend agricultural support and assistance to this Municipality that by virtue of devolution as it confers power and authority to the Local Government Unit of Bulalacao to perform specific functions and responsibilities;

"WHEREAS, confident and with good intention former Mayor Edna C. Villas and Mayor Ernilo C. Villas continue to develop the AC/BS investing more funds to modernize the area so that it serves its purposes that redound to the social and economic benefits of the farmers;

"WHEREAS, the Local Government Unit of Bulalacao is holding a copy of the Deed of Donation dated February 28, 1973 made by Aniceto Atienza to the Bureau of Plant Industry and the same was accepted by the former Mayor Dolores Bago representing the Local Government Unit of Bulalacao and nobody can revoke the said Deed of Donation except the Donor himself; Now, therefore, be it ...

Villas, et. al with docket number OMB-L-C-17-0433 for: RPC Art.. 282 – Grave Threats: R. A. 3019 Sec. 3 (e) & (j) and Romuel D. Atienza versus Edna C. Villas, et. al with docket number OMB-L-A-17-0469 for: Grave Misconduct";






