RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 4, CY 2017 OF BARANGAY CAMPAASAN AMOUNTING TO ONE MILLION FIVE HUNDRED SEVENTY THOUSAND TWO HUNDRED NINETY SEVEN PESOS AND NINE CENTAVOS (PHP1,570,297.09) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 17-12-009, DATED DECEMBER 11, 2017

“RESOLVED AS IT IS HEREBY RESOLVED To: Approve Supplemental Budget No. 4, CY 2017 of Barangay Campaasan amounting to One Million Five Hundred Seventy Thousand Two Hundred Ninety Seven Pesos and Nine Centavos (PhP1,570,297.09) passed under Sangguniang Barangay Appropriation Ordinance No. 17-12-009, dated December 11, 2017; with the following recommendations, to wit:

1. That, the procurement of supplies and materials is in accordance with RA 9184 (Government Procurement Reform Act);

3. That, the Sangguniang Barangay of Campaasan, Bulalacao, Oriental Mindoro is likewise advise to strictly follow the recommendations of the Local Finance Committee as reflected in the review letter attached herewith;






