ALARCON, GRANTING THE FORMER THE RIGHTS TO USE AND IMPROVE THE WATER SPRING OWNED BY THE LATTER SITUATED IN SITIO TUKTOKON, BARANGAY POBLACION, THIS MUNICIPALITY IN CONSIDERATION OF A MONTHLY RENTAL FEE OF THREE THOUSAND PESOS (PhP3,000.00) STARTING ON JANUARY 3, 2022 UP TO DECEMBER 31, 2025

RESOLVED AS IT IS HEREBY RESOLVED, To: Authorize the Municipal Mayor, Honorable Ernilo C. Villas to represent the Local Government Unit of Bulalacao to enter into Contract with Mr. Hermie G. Alarcon, granting the former the rights to use and improve the water spring owned by the latter situated in Sitio Tuktokon, Barangay Poblacion, this Municipality on consideration of a monthly rental fee of three thousand pesos (PhP3,000.00) starting on January 3, 2022 up to December 31, 2025;


RESOLVED FURTHER, That: Any change or alteration in the Contract originally presented shall have no effect and therefore null and void;


