ORDINANCE NO. 12-03-127

AN ORDINANCE ESTABLISHING THE MAUJAO MARINE PROTECTED AREA AND PROVIDING PENALTIES FOR ANY VIOLATION THEREOF

SPONSOR: Councilor Ramon G. Magbanua
CHAIRMAN: Committee on Agriculture

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. An area of marine protected area containing of Thirty Four and Half Hectare (34.5has.) is hereby set aside and established in Barangay Maujao, Bulalacao, Oriental Mindoro to be known as "Maujao Marine Protected Area" formed by the following coordinates:

From latitude 12° 17' 11.9" N	longitude 121° 18' 01.2" E
to latitude 12° 17' 09.0" N	longitude 121° 17' 55.6" E

SEC. 2. Administration and Control. There shall be created a Sanctuary Management Board within the Barangay Maujao who shall prepare the implementing rules and regulations and oversee the management of the marine protected area which composition shall be determined by the applicable order to be issued by the local chief executive.

SEC. 3. Prohibition. It shall be unlawful to conduct any kind of fishing operations within the hereinabove body of waters; or take, catch, destroy or kill fish and fishery/aquatic product or in any manner disturb or drive away or take therefrom any fish fry or fish egg.

SEC. 4. Penalty. Violation of this Ordinance shall subject the offender to the penalty of fine of not less than Two Hundred Pesos (Php200.00) but not exceeding Two Thousand Five Hundred Pesos (Php2,500.00) or by imprisonment of not less than fifteen (15) days but not more than six (6) months or both such fine and imprisonment upon the discretion of the Court.

SEC. 5. All ordinances inconsistent hereof are hereby repealed and modified accordingly.


