**RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2021-01, ANNUAL BUDGET FOR FY 2022 OF BARANGAY BAGONG SIKAT, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF THREE MILLION ONE HUNDRED TWENTY-ONE THOUSAND TWO HUNDRED SEVENTY PESOS (PHP3,121,270.00) OPERATIVE IN ITS ENTIRETY**

**“WHEREAS**, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

**“WHEREAS**, the Sangguniang Barangay of Bagong Sikat, Bulalacao, Oriental Mindoro submitted its Annual Budget for FY 2022 showing therein the sources of income and object of expenditures to this Sanggunian for review on January 10, 2022 pursuant to the provisions of Republic Act (R.A.) No. 7160;

**“WHEREAS**, the Annual Budget for FY 2022 of Barangay Bagong Sikat was duly taken by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session on February 14, 2022 and was found to be consistent with pertinent laws, rules and regulations;

“WHEREAS, the Sangguniang Barangay of Bagong Sikat, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the attached review letter which became integral part of this resolution;

“WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing rules and regulations of Commission on Audit and all other government agencies; Now, therefore, be it...
