### RESOLUTION NO. 23-05-149

**EARNESTLY REQUESTING THE MUNICIPAL MAYOR, THE HONORABLE ERNILO C. VILLAS TO PRIORITIZE THE APPOINTMENT OF A RURAL SANITARY INSPECTOR UNDER THE MUNICIPAL HEALTH OFFICE TASKS TO ADDRESS ISSUES CONCERNING ENVIRONMENTAL SANITATION**

**“WHEREAS**, pursuant to Article XIII, Section II of the 1987 Philippine Constitution, the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services;

**“WHEREAS**, the position of a Rural Sanitary Inspector (RSI) is left vacant for more than two years that there is a need to appoint a new one because of the widespread threat of malaria and dengue caused by mosquitoes. The RSI also address the problem on solid waste management, environmental sanitation, water analysis and to monitor the safety and cleanliness of food establishments and finally to implement the Environmental Sanitation Code of the Municipality;

**"WHEREAS,** the designated Meat Inspector had recently retired leaving behind his duties and functions of ensuring the safety of meat for human consumption. This could be another important task of RSI and taking into consideration the widespread of ASF viral disease affecting livestock and feral swine that needs to be controlled and eliminated;

**"WHEREAS,** the Sangguniang Bayan enacted two (2) ordinances such as **An ordinance Creating the Municipal ASF Task Force and Technical Working Group and adopting and implementing the Bantay ASF sa Barangay and an Ordinance Creating the Local Drinking Water Quality Monitoring Committee.** Both ordinances needs the expertise, dedication and hard work of the Rural Sanitary Inspector for its effective and efficient implementation.

**"WHEREAS,** the RSI prepares sanitation reports and maintains proper filing system and updates to the community. Sad to know, that the latest data used today is still 2019 according to the Municipal Health Officer;

**"WHEREAS,** the Local Government of Bulalacao seeks to promote the health, safety and sanitation and general welfare of the constituents by prioritizing death, injury, sickness and property damage. The LGU seeks to provide wholesome environment to its constituents conducive living; **Now, therefore, be it**

**RESOLVED AS IT IS HEREBY RESOLVED To:** Earnestly request the Municipal Mayor, the Honorable Ernilo C. Villas to prioritize the appointment of a Rural Sanitary Inspector under the Municipal Health Office tasks to address issues concerning environmental sanitation;






