“WHEREAS, Section 1, Article XIV of the Constitution provides that

education at all levels and shall take appropriate steps to make such education
accessible at all”;

“WHEREAS, the Mindoro State University (MinSU) is a public state
university located at Victoria, Oriental Mindoro that is mandated to provide
higher vocational, professional and technical instruction and training in
agricultural, fisheries and industrial fields; it is also mandated to promote
research, advanced studies and progressive leadership in the fields of
agriculture including agricultural education and home technology, with special
emphasis given to agricultural industry, fishery, forestry, and industrial
education; it has an extension classes in the Municipality of Bulalacao which
has been operating for five years now since 2018;

“WHEREAS, at this present time, the MinSU Bulalacao Extension
Classes does not have physical campus and the Local Government Unit of
Bulalacao just provided an old building where it can hold classes for the
students and administrative functions for its faculty and staff;

"WHEREAS, since the establishment of MinSU Bulalacao Extension Classes, the Local Government Unit of Bulalacao has been allocating funds for its operation and administrative expenses including the salary of its instructors and provision of financial assistance to its students, thus, this contributes to the exhaustion of the municipal budget;


"WHEREAS, for the continuous operation of MinSU Bulalacao Extension Classes, the Local Government Unit of Bulalacao is humbly asking the good Congressman Alfonso V. Umali, Jr. to include in its proposed annual budget the appropriation of funds for the said extension classes that would affirmatively support to its maintenance and overall improvement; Now, therefore be it...
